2nd SRNT IAHF Latin American Conference on Tobacco Control Report

2nd SRNT IAHF Latin American Conference on Tobacco Control, Mexico City took place on Oct 14-16, 2009. It was sponsored by the Society for Research on Nicotine and Tobacco (SRNT) and the National Institute of

Respiratory Diseases (INER) of Mexico and the InterAmerican Heart Foundation, which was the main organizer.



The Conference's theme was "From science to policy," focusing on science, policy, advocacy and treatment. It was the only and largest regional conference sole dedicated to tobacco control in Latin America and the Caribbean. The conference website: www.srnt-iahfmexico09.org.

RESULTS:

1. **Registrants.** 466 registrants from 28 countries or an increase of 30% over the 1st conference in

Rio de Janeiro, Brazil. The countries represented were: Argentina, Barbados, Bolivia, Brazil, Canada, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Guyana, Honduras, Jamaica, Mexico, Nicaragua, Nigeria, Panama, Paraguay, Peru, Spain, Trinidad and Tobago, United Kingdom, Uruguay, USA, and Venezuela.

- 2. **Scientific Program.** The program was timely, rigorous and action oriented. The presentations were structured to answer the questions "so what?", "what are the implications for our work in the region?" SRNT gave the conference its scientific and research base and the IAHF gave it its policy orientation.
- 3. **Plenary sessions.** The 6 plenaries consisted of one world-renowned major speaker and several experts from Latin America and the Caribbean that provided the experience and direction for our region. Topics:

Obstacles to implement tobacco control policies in Latin America: the tobacco industry;

Smokefree policies: implementation & evaluation; Litigation.

Tobacco dependence treatment and training: an update.

Maximizing quality in the treatment of cigarette addiction; and

The future of tobacco control in Latin America & the Caribbean: priorities, strategies, capacity building.




- 7. **Youth Advocacy.** Fifty plus young people met in Mexico City on October 14th, 2009 to discuss advocacy actions to control tobacco in Mexico. This was an activity of the regional network of youth advocates. Actions by this group included capacity building events, a Manifesto on Youth and Tobacco, press conferences, national and regional workshops, among others.
- 8. **2009 Journalism Contest on Tobacco Control Awards.** Winning journalists were announced. Recognized journalist came from Argentina, Brazil and Colombia this year. There was also recognition to a journalist from Mexico.



- 9. **Central America Tobacco Control Coalition.** Representatives from Central American countries met and organized a coalition during the congress.
- 10. **Launching of BILACCTA.** With the support of The Canadian International Development Research Center (IDRC), the BILACCTA web-based database has been launched helping researchers and advocates in the region to more easily find research studies, whether published, unpublished or in progress, by topic or country.
